INSTRUCTIONS FOR ABC IDENTIFICATION CARD APPLICATION

- 1. Fingerprints MUST BE DONE PRIOR TO SUBMITTING AN ABC APPLICATION. See attached page for information on how to make an appointment with Identogo for fingerprinting.
- 2. ABC applications can be located on our website www.littlesilverpolice.org or by visiting the Little Silver Police Department.
- 3. Bring a Valid government photo ID such as a driver's License or passport, \$25.00 (money order or exact cash only) and completed ABC application with YOUR RECEIPT from IdentoGo to the Little Silver Police Department for processing.
- 4. A temporary ABC card will be issued only AFTER completing the steps above.
- 5. Your permanent ABC Card will be issued once your background check has been completed. You will be contacted by a member of the Little Silver Police Department once your card has been finalized.
